



Valid certifications must be achieved. (List of certs change quarterly)

Claims are capped by Partner World membership level achieved

- Member \$6K
- Advanced \$15K
- Premier \$50K

Claims are capped by individual

\$6K maximum per individual per subscription year


Supporting documentation is e-mailed to IBM

 Reimbursement claim form-Copy of paid invoices and course attendance-Proof of achieving certification (given at time of test)





Process:



- Only courses and tests listed on the YPWP Reimbursable Certifications list are eligible for reimbursement. List is updated quarterly.
- Student has 60 days from the last day of class to achieve certification. If multiple courses are required, the 60 days starts from the last day of the final course.
- Certification is required for reimbursement
- The Reimbursement Claim Form must be submitted within 60 days of achieving Certification
- BP reimbursed within 60 days of IBM receiving all required documentation
